SPAW Community Guidelines

Introduction

These Community Guidelines define the standards that each user must follow when using the SPAW application. These rules aim to create a safe and positive environment for all users while complying with applicable regulations.

1. Prohibited Content

1.1 Inappropriate Content

The following content is strictly prohibited:

- Pornographic, sexually explicit, or suggestive content
- Content promoting violence, discrimination, hatred, or harassment
- Content containing threats or intimidation
- Content encouraging illegal or dangerous activities
- Content encouraging or documenting acts of vandalism or property destruction
- Content depicting or promoting the consumption of illicit substances
- Content promoting or glorifying the misuse of legal substances
- Content promoting excessive alcohol consumption

1.2 Substance and Alcohol Regulations

The following content is prohibited:

- Promoting the consumption of illegal drugs
- Glorifying or trivializing the misuse of legal substances (nitrous oxide, medications, etc.)
- Promoting legal substances in certain jurisdictions (cannabis, etc.) in a manner that does not comply with local regulations
- Violating local regulations regarding alcohol promotion and advertising, including:
 - o Promotion to minors
 - Encouragement of excessive consumption
 - Glorification of alcohol effects
 - O Promotional messages non-compliant with local legislation

1.3 Other Prohibited Content

- Content violating minors' rights
- Defamatory or slanderous content
- Content violating intellectual property rights
- Content containing identifiable personal information without consent
- Misleading or fraudulent content
- Content documenting or encouraging dangerous or illegal behavior in establishments
- Content encouraging non-compliance with establishment safety rules

2. Moderation System

2.1 Moderation Tools

SPAW implements a rigorous moderation system combining:

- Preventive automated filters for detecting potentially inappropriate content
- A reporting system accessible to all users
- Timely review of reports, with priority given to sensitive content
- Post-publication moderation of reported content
- Evidence preservation for illegal content requiring law enforcement intervention

2.2 User Participation

Users are encouraged to actively participate in maintaining platform quality by:

- Reporting inappropriate content through the integrated reporting system
- Providing accurate information when submitting reports to facilitate processing
- Avoiding interaction with problematic content pending moderation

2.3 SPAW Rights

SPAW reserves the right to:

- Remove detected inappropriate content
- Preventively suspend suspicious accounts pending verification
- Permanently ban users who violate rules
- Retain violation data to prevent creation of new accounts

3. Sanctions

3.1 Automatic Preventive Measures

- Temporary hiding of reported or suspicious content from other users pending moderation
- Temporary visibility limitation for suspicious accounts
- Content preservation for moderation review

3.2 Post-Review Measures

- First violation: content removal and warning
- Second violation: temporary account suspension (7 days)
- Serious or repeated violation: permanent ban

3.3 Appeal Procedure

- Preventively hidden content remains visible to its author until final moderation decision, thus preventing content loss in case of false reports
- Moderation decisions are final but may be appealed through the dedicated form in the application

4. Rules Updates

SPAW reserves the right to modify these rules at any time. Users will be notified of substantial modifications and acknowledgment will be required to continue using the application.
